

EDMONTON DIOCESAN PRESIDENT ANNUAL REPORT

41 of 62 councils reported

Sisters in the League:

Despite the restrictions from the ongoing pandemic in 2021, the annual reports confirmed the resilience of the CWL. We gathered to pray, check in on each other, and plan ways to continue our mission within our parishes and communities.

Women Shelters, Food Banks, School Lunch Programs all benefitted from donations made by our members.

Our 2021 theme, "Care for our Common Home: Fostering a Culture of Care," emphasizes the three pillars of the CWL: Service, Faith, and Justice. The Diocesan priority was to support our parish councils by holding workshops, offering training, and encouraging councils to find creative methods to engage with their membership. Diocesan Officers partnered with parish councils and maintained contact through Parish Buddy Calls.

Diocesan supported provincial and national initiatives by providing workshops on the Welcome Kit and navigating the procedures to hold instructed votes related to amendments to the Constitution and Bylaws 2013 and the Per Capita Fee Increase. Members were encouraged to complete the surveys and requests sent out from the Strategic Planning Implementation Committees.

Many councils participated in the Gratitude Card initiative to thank the frontline workers in their communities. Several participated in the Centennial Tree Planting Project. Diocesan Council partnered with St Joseph's Basilica CWL to plant a tree on the grounds of St Joseph's Seminary and Newman Theological College.

Diocesan held several workshops. Dr. Lia Daniels presented a workshop entitled "Motivation: Pandemic Style," addressing how to manage emotions and feelings through the pandemic. Two workshops related to Palliative and Hospice Care took place. The first workshop on May 1st was a two-part presentation by the Palliative Care and Euthanasian Coalition and the Olds Hospice Society. The second workshop, held in October, provided Volunteer training via the Compassion Care Committee.

Support for Catholic education remains a crucial objective. We launched the CWL Book Project to maintain our relationships with Catholic schools. The theme of the project was "To Each Their Own Story." Councils were asked to donate a book, "Everybody's Welcome" authored by Patricia Hegarty, to a local elementary school.

The 98th and 99th Annual Conventions were held virtually on May 15th to conduct business and receive annual reports. The Fall Meeting was also held virtually on October 2nd. We opened the fall meeting to pray for reconciliation and solidarity with Indigenous Peoples following Canada's First Truth and Reconciliation Day. We invited Fr. Susai Jesu OMI, Pastor of Sacred Heart Catholic Parish of the First Peoples, to speak on "Building Relationships with Sacred Heart Parish of the First Peoples." This parish

plays a unique role by incorporating the indigenous teaching, symbols, ceremonies, catholic scripture, and customs reflecting the coming together of both traditions. Diocesan Council has initiated a project to support the parish by contributing to the redesign of a stained glass window damaged during a fire in August 2020.

At the 2020 & 2021 National CWL Annual Meeting of Members held virtually on August 9 & 10th, 2022 three members of the Edmonton Diocese were elected to National Council: Fran Lucas, National President, Cathy Bouchard, Second Vice President and Spiritual Standing Committee Chair, and Dorothy Johansen, Christian Family Life, Standing Committee Chair. Diocesan arranged a small presentation following the election.

Declining membership continues to be a concern, at the end of 2021 membership was 3,771 members. Five councils moved to disband mainly due to aging numbers and the lack of members wanting to take leadership roles. On a positive note, Sacred Heart Catholic Parish of the First Peoples are working towards reactivating their council.

Sixty-six percent of the councils completed their Annual online reports in the Archdiocese; a majority used Diocesan mailings or meetings, the Canadian League magazine, national communiques, or websites to inform their membership about the league activities.

The top national priorities introduced and discussed at the parish level included Care of Our Common Home, medical assistance in dying from palliative care/hospice facilities, rights of the pre-born under the UN Convention on Rights of the Child.

Nearly all councils reported having spiritual advisor support, and among those, 39% met monthly, while 37% reported occasionally meeting with 98%, indicating the spiritual advisor is supportive of the CWL. The spiritual advisors participate in Memorial Services for members, saying masses for feast days like Our Lady of Good Counsel, attended meetings virtually, and blessed the Centennial Trees.

Constitution and Bylaws, the Council Policy and Procedure Manual, and Robert's Rules of Order were the principal resources used by councils. The Executive Handbook and the National Manual of Policies and Procedures were secondary references used by 42%. Other resources used were the Resolution Supplement and the National Association of Parliamentarians. The Alberta Association of Parliamentarians offered workshops and meetings via ZOOM.

Presidents represented their council at church functions (56%), Diocesan meetings and conventions (68%), World Day of Prayer (37%), provincial meetings (29%), and national conventions (22%). Other events noted were the Parish AGM, membership drives, and funerals. Due to COVID restrictions, presidents could only attend virtually (via ZOOM or webinars in 2021).

Almost all of the parish councils used The Executive Handbook, and all indicated it assisted them in overseeing their Council's operation. Of those reporting, 56% provide an annual summary to their members, delivered through e-mail (83%), oral report (61%), written means (57%), by newsletter or parish bulletin (less than 44%).

Nearly 54% of the councils have funeral lunch committees, and 37% reported having annual events like

teas bazaars, 30% have social events, 39% have fundraising activities, and 30% make yearly donations. Other committees mentioned were the Parish Liaison with Parish Pastoral Council, mentorship and new members committee. Several councils indicated no committee work due to COVID restrictions.

Parish presidents indicated few opportunities to speak on behalf of their Council in 2021 though several implied communications were mainly through e-mail, and some used virtual meetings. Topics included World Day of Prayer, the instructed vote on amendments to the C&B 2013 and per capita national fee increase, Memorial Mass for Members, and membership drives.

When asked about the communications received from other league levels, 68% reported satisfaction from the information received from Diocesan Council compared to 42% from Provincial Council and 39% from the National Council. Diocesan Council provided the most relevant material at 60%, while Provincial was at 42% and National at 34%. The communications from Diocesan Council were 63% being clear and concise, and Provincial and National Communications perceived at 42% for clarity.

Transitioning into the roles of presidents, past presidents provided significant assistance, followed by other executive members. Nearly 40% indicated the Diocesan President provided needed guidance.

Councils reported that the most significant challenges faced when transitioning into the new roles included keeping members interested (56%), recruiting (42%), feeling overwhelmed and not having a full slate of officers (37%), the large amount of paperwork (29%), feeling untrained (24%) and resistance to new ideas (24%).

Comments from presidents concerning what they are most proud of included the executive's willingness to participate even in this time of COVID restrictions. Other achievements included care for each other, meeting virtually to pray the rosary together, commitment to social justice and right to life, members' dedication, and wanting to better our community and parish. The biggest challenges were keeping members motivated, gathering socially, and recruiting new and younger members.

Despite the restrictions of the pandemic over the last two years, it was gratifying to witness the dedication and the love of the league reflected in the president's and standing committee chairs reports. Through their leadership and work of their councils the future of the league is secure.

May Our Lady of Good Counsel continue to guide and bless us

Sisters in the League,

In spite of the trying times, we have experienced this past year coping with COVID restrictions and being creative in developing ways to carry on our CWL business, our Parish Councils have continued to strive and accomplish wonderful things. I have recapped the statistics reported by the Parish Council Secretaries.

Thirty-eight of the 62 councils (61%) of the councils in our Edmonton Dioceses completed their annual reports. This is much higher than last year -54%. All responding councils have either a recording secretary and/or a corresponding secretary while 63% of councils report one person holds both positions. 50% of council secretaries were appointed, 45% elected and 5% the position is vacant. The average number of years secretaries have held the position is 4.

All secretaries reported they take minutes and 32 reported they are a signing officer for their council. The majority of the council secretaries know where their council charter is and maintain a list of the executive members and their contact information. Nineteen councils maintain a motions book and 18 receive written reports from their executive, 33 have a copy of the National Handbook for Secretaries and 20 report they have a copy of the National CWL Personal Letter Writing Guide.

COVID-19 was the biggest challenge this year; much the same as in 2020. Councils were unable to hold in-person meetings, but most were able to meet virtually a few times during the year via ZOOM but frustrating at times due to unreliable internet connections for rural councils. One council reported many members do not have internet, so ZOOM is out of the question.

It is important for presidents and secretaries to keep in touch, either by phone or email in order that information is sent to members in a timely fashion. Some council executives continued to meet monthly virtually. Some councils developed "buddy lists", calling members just to chat and keep in touch. Some councils have a large elderly membership who are not comfortable with technology, so a lot of mailing takes place. This creates hardships when there are items to be shared with members from the Dioceses or National. They just can't keep up with reports and activities. One council reported, and this seems to be prevalent with a lot of councils, before COVID they had less than 25 members attend meetings, including executive. They are concerned what the numbers will be when regular meetings resume. This pandemic has created many hardships on our members. Most secretaries keep up with email addresses so members can be kept informed.

Another area of concern is getting together to vote on the amendments sent out by National in 2020. Of concern for a lot of council members is the increase in per capita fees and changing our Patroness. They understand National needs the funding, but the concern is if the increase is successful, members will not renew. They would like National to come up with different ways to raise the much needed funds other than increasing the per capita fees.

Other challenges with not getting together expressed were getting minutes signed by the president, getting cheques signed, passing motions, and voting during virtual meetings. Audio recording the meetings was helpful in taking minutes. Close to 50% of all councils reported they were satisfied with the communication they receive from National, Provincial, Regional and Diocesan Councils

whereas 33-42% considered the communication from the same councils to be relevant. Close to 50% of councils receive duplicate communication and the same number report they do have enough time to respond to invites/requests to participate.

In closing, some additional comments received from secretaries' worth sharing:

- personal contact and the group enthusiasm always present at monthly meetings was greatly missed
- very thankful for ZOOM and other means of virtual communications which have made things easier and more accessible
- it would be helpful if memos were posted on the National Website making accessibility timelier
- have National advise us when new material is added to the website; have a Secretary's Workshop.

TREASURER'S ANNUAL REPORT 2021

36 of 62 councils reported

Sisters in the League,

In reading the 2021 recap Treasurer's report from National I was not surprised by any of the results. We did have 7 less councils submit their reports than the previous year, which brings us back to the same reporting % as in 2019.

Our councils continue to balance their books on a monthly basis and report to their councils the activities of the previous month along with outstanding items. There are some councils who have not been able to get their financials records reviewed due to COVID restrictions. Please note that these should not be forgotten but reviewed as soon as possible. I cannot stress how important it is to have your books reviewed on an annual basis, you don't want to be one that is losing funds due to mismanagement of the account.

I was pleased to see that 64% of the councils that reported produce a yearly budget. Even when funds are tight, it is still prudent to create a budget for the year.

As expected, the financial contributions have decreased from last year. At the National level the average contribution is down by 20%. Donations made to the parish was down by 40.58% and other donations was down by 36.47%. Considering the inability to do any of our usual fund-raising activities, the total contributions made was still \$76,017. Remember this amount is only from the 36 councils that did report, so taking into account the lack of fund raising, it is still wonderful that so much was donated.

Here is a quick recap of the contributions for the Annual Parish Donations sent to the Diocesan council:

\$1,563 \$9,630
\$1,385
\$2,780
\$ 580
\$1,955
\$2,930

This is an increase of overall donations by \$262.00 – way to go councils.

Unfortunately, our contribution commitment to St. Benedict's Chapel was insufficient from the donations received for the 2021 payment. The shortfall of \$2,790.00 was covered under Donations/Extra Ordinary Expenses in our 2021 Budget. This made the line item over budget but due to the restrictions on travelling and meetings, we were still within our overall budget by year end. In reviewing the donations, I predict that we will still be in a shortfall for the 2022 payments, unless more donations are received by June of this year. As of March 1, 2022, we still have another \$1,595 to collect prior to June 1st, 2022.

Considering the restrictions that were in place in the past year, you are still giving where and when you can. We can only hope and pray that this year will be better than the previous two.

PAST PRESIDENT'S REPORT 2021

25 of 62 councils reported

Sisters in the League,

The role of the past president is to mentor, advise, listen and undertake assignments from the president. A past president is a tremendous resource to their council as they have experience and knowledge of League matters including publications such as the Constitution & Bylaws and the Policy & Procedure Manual. They may be called upon to help review and update policies in their councils from time to time.

The majority of Past Presidents reported that they attended Executive meetings, General meetings, social events and spiritual events.

Past Presidents were called upon monthly for advice and the President and council members felt supported by their help.

Past Presidents are responsible for maintaining and securing the history of their council. Half of the reporting Past Presidents indicated they were responsible for archives of their council. Council archives were mostly stored at the church in a designated CWL room, cupboard or filing cabinet. These materials were stored in photo albums, scrapbooks, banker boxes and on memory sticks. The majority of the councils knew the whereabouts of their council charter.

When asked how long councils kept documents and archival materials, items that were kept indefinitely were Annual Reports (55%), Book of Life (90%), Deceased member histories (76%), lists of past executives (69%), membership renewal data (55%), minutes of Executive meetings (51%), minutes of General meetings (62%), record of service awards (62%) and years of service (79%). Council archives were reviewed as needed by 82% of councils. 68% of councils reported maintaining a history book and 90% of councils reported having labelled photo albums.

One of the duties outlined in the Constitution & Bylaws (C & B) is that the Past President shall facilitate the study and implementation of the C & B. All councils reported having a copy of the C & B and reviewed it as needed. 86% reported having the National Manual of Policy and Procedures and referred to it annually. 76% of reporting councils had their own manual of policy and procedures and updated it whenever policy changed or reviewed it at least once in a two-year cycle. Providing support and mentorship to councils to create their own manual of policy and procedures will be my goal for the next year.

When questioned as to what levels of the League councils would seek advice, the most communication was with the Diocesan Council with 41% of councils seeking advice at least once per year, provincially 23% at least once per year, National Executive 14% at least once per year and National Office 14% at least once per year. 37% of councils reported seeking advice from their spiritual advisor at least once a month and 24% of councils reported seeing advice quarterly. The majority of reporting councils did not seek advice from their local bishop and 72% of councils rarely or never sought advise from Life Members. Life Members are available to serve, and I will be encouraging councils to engage in this opportunity

Those reporting were asked to share what they could do to make their successor's experience more enjoyable and fulfilling. Many answered to provide encouragement, open communication and offer a listening ear while supporting in any capacity. Providing mentorship and training to help the new president transition into the role and always attend meetings to be a resource as needed.

When asked to share a great success, many councils said learning and successfully setting up virtual meetings via Zoom and keeping in touch with members regularly.

The greatest challenge by many Past Presidents was COVID-19 restrictions and keeping CWL visible in a pandemic lockdown. Fortunately, virtual meetings were introduced and that provided a new way for us to get together and keep motivated. Recruiting new members and collecting membership dues as well as finding members to take on leadership positions provided challenges for many councils.

It's important to recognize the future of the League depends on each member continuing to share their own special talents. For those invited to run for a Diocesan officer position, say "yes". If you have already served a parish council leadership role, the Holy Spirit may be calling you to expand your faith life further.

SPIRITUAL DEVELOPMENT ANNUAL REPORT 2021

Dear Sisters in the League,

God works in mysterious ways, and we are sure to be stumped if we attempt to "know the mind of God." We do however, trust that God's plans – even though they are not our plans – are meant for our good and our growth. (Isaiah 55).

Over the past year, I have attempted to connect with our members through sharing resources available for either their personal or council use on topics such as: World Day of Prayer, Week of Prayer for Christian Unity, and National Day for Truth and Reconciliation, I have used the Vatican website for updates and announcements re. these important topics for educating and informing our ladies. Updates from the Implementation Committee with resources for the core values of *faith* and *social justice*, both of which fall within this standing committee. At our Diocesan Convention in May, we gathered virtually to hold the Memorial for Deceased Members from 2020. Of course, it's not the same as *being* together to remember these our sisters, but it offered the opportunity for some of our members who would not normally be able to participate to join us.

Many thanks to those of you who completed the annual report for this standing committee. Of our 62 councils, 30 reported and almost all had this position filled! What an inspiring fact! Many councils were able to take at least some action on the national theme of *Care for Our Common Home* with many trees being planted. One of our councils actually planted 100 trees in a natural area in honour of the League's 100th Anniversary! There is a widely used practice of balancing the faith, business and social aspects of our meetings. Our women became creative in finding ways in which they could honour their deceased sisters with *Honour Guards* as well as ways to pray together without being together! Women found ways to honour Our Lady of Good Counsel through online discussions, mass, prayers, education about her history etc. The introduction of *National Faith Day* as an annual event was too close to the actual day and did not provide our councils enough time to plan for the event which I'm certain will be widely celebrated in the years to come.

Spiritual Advisors support the work of CWL in their parishes as time allows. I truly hope that we can nourish these relationships more consciously, garnering growing awareness of the critical role that CWL councils play in the life of the parish, and encourage a more visible support from our pastors who play a key role in the ability of our councils to flourish. Half of the respondents to the annual report indicated that they use resources from the National website. There are some practical, enriching resources that are now available that have been gifted to the League by the Implementation Committee working groups in the areas of both faith and social justice. The diversity of prayer resources be it written, video, local or international is truly amazing and there waiting for you to use.

Many councils reported highlighting the role of women in the church. "Catholic women's role in the church is often in our minds and in our actions." Most councils have as yet not addressed the

encyclical *Fratelli Tutti* but almost all councils responded to Pope Francis' call to pray the rosary in May. Our councils continue to support Catholic Missions in Canada and are key participants and leaders, in virtually EVERY ministry within our churches. There is, at this point in time great potential for improving interaction and contact between women of other faiths and denominations.

World Day of Prayer was the most significant way of encountering our Christian sisters. I would suggest that there is a growing awareness of our Indigenous sisters and a desire to do a better job of making connections with them to build better relationships. For example, "We promoted the online Lac Ste. Anne pilgrimage to our members." "Our members were encouraged to participate in two retreats pertaining to Truth and Reconciliation to foster a better understanding of our relationship to First Nation Peoples." I find great comfort in knowing that the "National Day of Truth and Reconciliation" as well as "Orange Shirt Day" will become regular events in our councils across the diocese. There are far too many inspiring examples of ways in which our women lived their faith last year in spite of all the obstacles. Such good news needs to be shouted from the tops of the mountains to every corner of our churches. You are God's prophets, and nothing will shut you down! Thank you for being an inspiration to me,

ORGANIZATION CHAIR ANNUAL REPORT 2021

Dear Sisters in the League,

Despite the continuation of gathering restrictions due to the COVID-19 pandemic, parish CWL councils and members found ways in the past year to stay connected, predominantly through the extensive use of virtual meeting platforms and phoning one another. These efforts helped to keep members engaged and informed about CWL initiatives throughout the diocese and to identify needs within their local community.

The Edmonton Diocese had 3,771 members in 2021, representing a decrease of 464 members compared to 2020. This is just over a four-fold drop in membership compared to that which was observed between 2020 and 2019. In addition, 5 parish councils voted to disband or go inactive. The decrease in number of active members in the Edmonton Diocese is also being experienced in all diocese and regions of Canada, underscoring the ongoing effects the pandemic has had on all League activities and the importance of League members staying connected to one another as much as possible.

In late 2021, at the invitation of Father Susai, pastor of Sacred Heart Church of the First Peoples in downtown Edmonton, the Edmonton Diocesan Council began meeting with the amazing women at the parish to begin the process of reactivating Sacred Heart's CWL Council. These women are the heart of a vibrant and active community that strives to serve the needs of the poor and the local community. Sacred Heart Church was one of the original councils that formed the Catholic Women's League. Today, Sacred Heart Church of the First Peoples is a beautiful example of Indigenous traditions and practices being celebrated within the Catholic faith. In early 2022, Sacred Heart's council will be reactivated. I invite all councils in the Edmonton Diocese to extend a warm welcome to our newest sisters in the League!

Many councils reported that the single biggest challenge encountered this year has been the inability to meet or to attend mass in person due to public health restrictions. In-parish activities are vital to the League's sustainability. In-person activities at the parish not only help members stay engaged in the League, but the church parish is also the place where the vast majority of membership recruitment (e.g., stewardship fairs, tables set up for membership drives, announcements before/after mass) and memorable League activities (e.g., teas, dinners, potlucks, fundraisers) take place. Most importantly, the church parish is where we join our League sisters to worship God together and to grow in our Catholic faith. For much of 2021, most Catholic parishioners in the Edmonton Archdiocese attended mass on-line which did not provide the opportunity to attend mass together. Our shared faith is our glue and being able to gather at local church parishes is important for us to stay connected. As soon as health restrictions ease to allow councils to return to in person meetings and activities at local parishes, I encourage CWL councils to return to reconnecting in person once again.

With heavy reliance on virtual meeting platforms over the past year, most Organization Chair positions were filled by appointment; most having held the position previously. This was also

observed in 2020, but to a greater extent in 2021. In particular, it was noted that in many council members are not letting their names stand for President-Elect at election time. Many members are willing to help take care of Organization tasks (i.e., 83% of councils renew memberships online), but are apprehensive to take on the role of council President in the subsequent term. This results in a chronic vacancy in the President position. While this trend was also observed prior to the pandemic, the shift to online meetings has likely increased the reluctance of members to take on these two important positions. The average council executive in 2021 had only 7 out of 11 positions filled (4 by election and 3 by appointment); remaining positions were left vacant. Good mentorship is best provided one on one in person over time. Please encourage new members in your parish council to take on an officer position and to think about one day stepping into the President-Elect or President role. Recognition of each member's gifts and talents and spending time getting to know one another better can really boost confidence.

On average, parish councils have 3 members aged 16-24. Some councils have fewer, some have more. What types of activities does your parish council offer for its younger members to get involved with? Are younger members encouraged to lead special projects in your council? Are younger members buddied up with older members or provided with mentoring in any way? Annual report surveys indicate the majority of council members participate in less than half of council activities. Only about 10% of members participate in the majority of council activities. That means there is room to grow! And one way parish councils can invest in the sustainability of their council is in encouraging younger and newer members to take on special projects and provide them with mentoring to help prepare them to take on executive positions down the road. Want to know which types of events have the highest participation? Those related to spiritual development! Remember, our shared faith is our glue. Younger members may still be growing in their faith and seeking opportunities to enrich their spiritual development while learning from more experienced sisters in the League about how to navigate life's ups and downs. Councils that provide these types of opportunities for younger members and parishioners are likely to find participation increases and memberships grow.

In order to encourage a wide cross-section of members to join the League, most parish councils found reaching out by personal invitation to be the most effective. In 2020, the National CWL introduced its Welcome Program which was disseminated as a workshop by the Edmonton Diocesan Council virtually with materials sent out to all parish councils via email. As such, most parish councils in the Diocese were familiar with the program. While only 7 councils reported implementing the Welcome Program in their parish, most councils are engaging new members through conversations and invitations and welcoming new members at meetings. Fourteen councils provide new member kits.

Councils across the Edmonton Diocese worked hard to recognize members for years of service, birthdays and milestones via phone calls, cards and announcements. Most councils were able to present service pins to their members and one-third were able to hold a new member ceremony while abiding by social distancing guidelines. Other councils recognized members through the presentation of awards, certificates, and small gifts. One council awarded the Bellelle Guerin Award, and twelve councils awarded the Maple Leaf Service Pin! Four councils were able to hold reaffirmation ceremonies.

The vast majority of CWL members do not have a role in levels of the League outside the parish council (e.g., Diocesan, Provincial or National levels). Seven councils have members who serve on

the Edmonton Diocesan Council, three councils have a member that serves on the Alberta Mackenzie Provincial Council, and three councils have a member that serves on the National CWL Council (National President, National VP/Spiritual Development, and National Christian Family Life). In some cases, the same parish council may have multiple members serving at other levels of the League (eg a member on Diocesan and a member on National Council). Parish councils report being most engaged with the Diocesan level compared to Provincial or National levels. Eleven councils reported having a life member who actively provided mentoring and advice in the past year, which is an increase from 2020.

CHRISTIAN FAMILY LIFE CHAIR **ANNUAL REPORT 2022**

28 of 68 councils reported

Sisters in the League,

Our activities in the League for 2021 were defined by the parameters of the pandemic, most being conducted virtually. The bright side was that more sisters were becoming comfortable with the formats, virtual attendance was up, travel in bad weather was down, and we could comfortably ensconce in our own place.

Common concerns from my Parish Buddies were aging members and lower membership. Councils kept connected to their sisters by phone and cards, and clever ideas to raise funds showed our ever creative perseverance.

Throughout the year my attendance at meetings, workshops, webinars were all virtual. Included were Diocesan Regional Meetings, World Day of Prayer, Euthanasia Prevention Coalition/Diocesan sponsored Compassionate Care workshop, WUCWO on Child Abuse, Knights of Columbus Stewardship series, GRACE Educational forum, online live Rosaries, March for Life, 12 hours for Palliative Care, Diocesan Workshops for individual Councils, National Convention, Parish Buddy calls, and one socially distanced brief in-person visit with the Carmelites in Devon. Our adopt-a-Seminarian program had 37 Councils adopting 29 Seminarians. Please keep them in your daily prayers. I sent out two communiques with links to pro-life organizations. In response to the 2019 annual survey, I started the process for a February 2022 presentation on Marriage-divorce-nullity, which had not yet been addressed.

In the Annual Survey, 28 Councils participated, representing seven cities and thirteen towns. Keep in mind that all activities were curtailed by COVID restrictions.

Family life issues included Sacramental support in Marriage, Baptism, First Communion and Confirmation, Prolife issues like Pregnancy care and women's shelters were mostly addressed through phone calls, prayer, cards and donation of cash, clothing or food. Half of the Councils were members of a prolife organization and participated, if possible, in person (life chain). 68% wrote to legislators about pro-life issues or signed petitions. For youth, one parish had a Catholic Girls League, and three were promoting World Youth Day in Portugal for 2023. Support was also in prayer, scholarships, Christian Leadership awards, Sacramental preparation gifts. Seniors and disabled were mostly sent cards or phoned. 96% of Councils adopted a Seminarian, sending prayers, spiritual bouquets, cards and gifts (money during Covid) and inviting their Seminarian to virtual meetings.

Areas that could be addressed are <u>bereavement help</u> for widowed, divorced or separated. Only two councils sponsored Pope John Paul II "Theology of the Body". This is an area that should be promoted more, especially in our Catholic Schools. Christopher West has a good program on this topic.

100% councils did not address divorce & annulment. Hopefully this will be remedied on February 16, 2022 with the presentation by Archdiocesan Judicial Vicar, Fr. Creurer. I encourage all councils to download the Brochure on "Marriage, divorce, annulment" from the National CWL website, under resources, and offer them to your members or in your Church.

This brief summary does not do justice to the depth and variety of the activities of our dear sisters in the League. I suggest Councils read the more detailed annual report for ideas. Many thanks for all you do. Let us continue to inspire and support each other and look forward to when we can once again share in person our Faith and strength.

COMMUNITY LIFE CHAIR ANNUAL REPORT 2021

Sisters in the League,

It is wonderful to read some of the great activities our councils are still able to do during this time. There are still numerous challenges during this time of COVID, it has somewhat been overcome with virtual meetings, but there are those councils that are not into technology which then mail outs and phone calls help out.

A number of councils participated in Orange Shirt Day, the Prison Ministry, prayers were offered up and funds were donated to help support Christians in the Middle East and the Holy Land, children were supported through Chalice, support to the Mustard Seed Project and Habitat for Humanity, homemade quilts were donated to a Women's Shelter, collection of items for our Refugee Welcome Bag Project, Bag lunches were made up for the inner city, there was a Baby Bottle Fundraiser, donations to the local food bank, baked goods were delivered to CWL members to the elderly and shut ins for Christmas.

For our Refugee Welcome Bag Project there were 111 bags sent out for 299 refugees that were looked after in 2021. Thank you to Anita Patsula and her team at the Basilica. There were communiques sent out and contact made various times throughout the year with the Parish Buddy Call Out and attended virtually monthly Diocesan meetings. In May I attended the virtual presentation on Palliative Care. I participated in Orange Shirt Day and attended a Truth and Reconciliation Mass in September. In the fall we had a virtual workshop on "Compassionate Community Care" which was well attended by members.

I'd like to address that there were some concerns in the Annual Report from National that there was too much going on under Community Life. The topics of the Community Life are dignity and rights of persons, social and economic justice, refugees, support for our Indigenous sisters, and the work of Development and Peace. For those councils that have concerns/questions about your chair position, we, the Diocesan Chairperson are an email or a phone call away.

EDUCATION AND HEALTH 2021 ANNUAL REPORT

Sisters in the League,

Education:

Throughout 2021 most of our CWL Councils have been keeping informed about the quality and availability of Catholic Religious Instructions in their respective parish and schools. That included encouraging parental participation in all areas of school activities and working together towards meeting the needs of their Catholic schools for sacramental/faith development, breakfast or lunch programs, and school supplies.

Most councils do not have a Catholic university or college within Parish boundaries. However, the majority either have established, or contribute to, a bursary or scholarship for university students. One council supports a young woman entering the Dominicans. Councils support their seminarians.

Some reported being unaware of the 'National Bursary Fund' and that suggests a need to follow up and inform all councils and their members about this fund.

In May 2021, Education and Health conducted a Zoom workshop on Hospice and Palliative care that was attended by more than 90 members.

"Everybody's Welcome", a novel by Patricia Hegarty, was chosen for 2021's 'Book Project'. This was the first year Edmonton Diocese CWL Councils were asked to purchase and donate copies of a designated book to their local elementary schools. Councils that participated subsequently reported being quite pleased with the good reception they received from their schools and libraries for this new undertaking.

Health:

Councils continued supporting national organizations focusing on the health and wellness of Canadians such as Cystic Fibrosis, Heart and Stroke Foundation, Kidney Foundation, Multiple Sclerosis of Canada and The Canadian Blood Services Partners for Life Program. Council members were encouraged to register for the Partners for Life Program under the League's unique Partner Id (CATHO11269).

'12 Hours of Prayer for Palliative Care' remains a prime focus for CWL members participating in the 12 hours of prayer either in homes, via zoom meetings or by telephone.

Environment:

Councils participated in the Care for Our Common Home Initiative and many took part in their neighborhood cleanup and that included church parking lots and sidewalks.

Many celebrated the 100th anniversary of the CWL by planting trees. One council planted 100 trees and installed a metal park bench. Environmental issues being addressed are recycling, reducing use of Styrofoam cups, composting, elimination of plastic straws and plastic water bottles.

Genetics:

CWL members want more information in order to have a better understanding of the advantages and disadvantages of the technology designed to alter genes in light of the teachings of the Catholic Church. Some suggestions submitted to help them are for councils to have access to workshops, resources from the Catholic Church, and group discussions on altering genes.

Note: Other subjects Councils request more information on are High Schools' religion curriculum, Catholic Church readings and traditions, how to reduce at home water consumption, recycling, minimizing and eliminating the use of plastics. Councils say it would be most helpful for them to have up to date information on the above subjects, before scheduling their council's activities for the next year.

COMMUNICATIONS ANNUAL REPORT 2022

29 of 62 councils reported

Sisters in the League,

The continuation of the COVID-19 pandemic has resulted in a very disconcerting year. Despite the uncertainty, the councils in our Diocese have continued to be active and engaged and for that we are very grateful. Twenty-nine councils submitted their Communications Annual Report surveys although only 16 (55%) of those councils have the position filled. Thank you for your dedication as this information is very useful to our Diocesan council as well as the Provincial and National councils, as we move forward with changes to the Catholic Women's League of Canada.

With the inability to meet in person, written and electronic communication was our main source of information however many councils continue to use telephone committees to disseminate information. The majority of councils used email (97%) and church bulletins (76%) as their main sources of communication. Most councils have encouraged their members to use the national website to access information.

Unfortunately, the councils who responded showed limited interest in the articles published in the Winter, Spring and Fall editions of Be League. It is important to provide your diocesan with feedback and input on what types of information you would like to see included in these publications so that can be reported back to National.

There are various ways to access information. National has a website as well as a presence on Facebook and Twitter. While a majority (90%) of councils have encouraged members to access information on the website, only 66% have encouraged members to visit the Facebook or Twitter pages. Fifty-five per-cent of Councils shared the National strategic planning information with their members and there is increased awareness of the strategic planning monthly updates on the national website. The Renewal Prayer is being recited with the lack of meetings over the past year, uptake is only at 41%.

Councils were very receptive to promoting information and awareness of the National Day for Truth and Reconciliation with 66% of councils promoting this. The April 26th League sponsored Our Lady of Good Council Mass was shared by 79% of councils.

Publicity does not seem to be a high priority with only 7% of councils including this as a line item in their budget. It is encouraging to see that 59% of councils produce a newsletter which they distribute to their members mostly by email. Forty-eight per-cent of respondents distributed their newsletter by mail. Most councils (79%) do not work with local media for the benefit of the League however 2 councils invited the media to an event and 2 councils used the media for advertising purposes.

There was very little uptake on the League's **Pornography Hurts** postcards, with 90% of councils indicating they did not participate in 2021. Thirteen per-cent of councils held information sessions on the *Over 18* documentary and none of the councils promoted the *Red Light Green Light* film.

There was very little action taken on the three communications-related resolutions and, although 45% of councils encouraged members to become educated on internet safety and responsible and appropriate technology use as stated in **Resolution 2017.02 Mandatory Age Verification Mechanisms for Adult**

Pornography Websites and 24% of councils contacted members of parliament, the minister of justice and/or the prime minister requesting this legislation, only 17% of councils monitored the federal government's response to the issue.

In response to **Resolution 2004.11 Link Between Graphic Imagery and Aggressive Behaviour and Mechanics of Killing,** 7% of councils have written to provincial/territorial governments to establish procedures to prohibit the sale and/or rental and/or distribution to minors and 7% ensured that the education system contains required curricula to provide students the tools to respond thoughtfully and critically to media content. Fourteen per-cent of councils encouraged the federal government to continue supporting research and development of tools to protect children against offensive content in the internet as stated in **Resolution 2002.11 Responsible Internet Use for Children.**

The national website, which was accessed by 79% of councils brings a feeling of "connectedness" with sisters in the League and overall, is very useful and informative, however there was some concern about the website being "too busy" and "difficult to navigate". One suggestion was to have the National magazine accessible from the Home Page as it is difficult to find.

Recruiting members to chair and participate in this standing committee is one of the biggest challenges of this committee. Councils reported that the lack of "in-person" meetings seriously limited their ability to contact members, especially, those councils with very senior-based members who were challenged with Zoom meetings and email communications. The other major challenge was keeping members interested in the council because of the limitations on in person meeting.

Despite the challenges, Councils are striving to keep their members aware of issues and communicate to their members about meetings, events and activities they hold.

Some councils managed to engage their members, even without in-person meetings. They held plant sales, prepared hampers for needy families, sold hand crafted cards, published a CWL cookbook, sent members monthly videos that matched the theme of the spiritual year and sewed/gifted baptismal stoles with the crests of Our Lady of Good Council and Holy Baptism on them.

Pope Francis, in his message for World Communication Day, emphasized the quality of *listening*, which he said "is decisive in the grammar of communication and is a condition for genuine dialogue." He invites us to reflect that listening involves more than simply the sense of hearing. True listening is a foundation of genuine relationships and is foundational to the relationship between God and humanity.

Let us all take some time to truly listen and as we begin to gather, in-person again, this is going to be truly important.

RESOLUTIONS AND LEGISLATION ANNUAL REPORT FOR 2021

24 of 62 councils reported

Sisters in the League,

Resolutions

Resolutions, beginning at the grass roots level, are the opportunity to collectively voice our CWL concerns, and ultimately, to effect change.... to make our voices heard!

All members should be encouraged to raise discussion, in their local CWL meetings, of challenges in their schools and communities; issues related to the environment, education, health, justice and society in general. Subsequently a decision to do or not do something is made by a vote.

When the local members agree something needs to be done, a proposed resolution should be drafted and submitted to the Resolutions and Legislations Chair.

No resolution was researched, developed, or submitted for adoption in 2021. Councils believe euthanasia, assistnce in dying, palliative care, abuse of seniors and Canada's commitment to the United Nations Convention on the Right of the Child need our ongoing attention.

The Councils' deep concern regarding these issues were brought to the attention of their local, provincial and federal government representatives, via, letter, email and telephone campaigns. One Council had an in-person visit with their local provincial and federal government contacts.

Throughout 2021, due to the pandemic, all local, diocesan, provincial and national meeting was virtual i.e., audio, video conferencing, screen sharing, or webinar.

The Resolutions Chairpersons from the 21 Councils reported 3 Resolutions Standing Committee positions were filled, 2 appointed and 1 elected.

Note: Some Councils have requested a motivational speaker be made available to attend a meeting, address current issues and inspire more member' participation. Is there such a speaker?

Legislation

Legislation is one of the most important instruments of government in organizing society and protecting citizens. It determines amongst others the rights and responsibilities of individuals and authorities in Canada, to whom the legislation applies. To ensure every piece of legislation reflects our beliefs and wellbeing, Councils' members are to be continually encouraged to monitor and ensure that they have input into all activities of every level of government where necessary and as deemed appropriate.

Of the 23 Councils completing the Legislation Annual Report for 2021, 5 Councils indicated they now have a new 'Legislation Standing Committee Chairperson' - 3 appointed, 2 elected.

The survey indicates most Councils feel their members are somewhat informed about issues being discussed by government at all levels. 14 Councils say they are aware of the Federal Bills currently being monitored, i.e., Bill C6, C7, C31, C-233, Bill C 268.

Some found the surveys difficult to complete and not user friendly. This suggests the need to review and determine whether or not the surveys' format needs to be revised.

STANDING RULES FOR ANNUAL CONVENTION 2022

- 1. Robert's Rules of Order Newly Revised shall be the parliamentary authority in all cases not covered by the Constitution & Bylaws of The Catholic Women's League of Canada.
- 2. Each person attending the Convention shall register at the Convention Registration desk and shall be required to wear the official Convention name tag for admission to all meetings.
- 3. Voting by registered members shall be by voting card only, which is issued upon registration.
- 4. Parish instructed votes must be received before Voting delegates participate in the instructed votes during business sessions. Instructed voting occurs with no discussion on the proposals.
- 5. Motions, amendments, and amendments to the Resolutions must be submitted in writing, on a Motion form, initialed by the mover and the seconder and submitted to the secretary. Only Voting and Accredited delegates may move or second a motion.
- 6. The member presenting a Resolution or Motion, or her designate, may speak for a maximum of three minutes and, when discussion on the Resolution or Motion is to be concluded, that member or her designate shall have a further two minutes for answer and rebuttal, if desired.
- 7. Any member may speak to any motion or ask questions in discussion. When time is of the essence, voting members shall be given priority to speak over non-voting members.
- 8. A member may speak only once to any one motion for a maximum of one minute (unless the assembly grants permission by a 2/3 vote without debate).
- 9. The Chairperson shall call speakers in the order in which they stand behind the microphones. Speakers shall use a microphone, address the Chair and state their name, delegate status and council.
- 10. No materials of any kind shall be distributed during the Convention without the express permission of the Edmonton Diocesan President.


