**SUBJECT: Past-President's Communique November 1, 2022**

Greetings Past Presidents! The position of Past President offers many opportunities to get to know the new executive and elected officers in a consulting capacity. There are three primary duties outlined in the Constitution & Bylaws and Handbook for Past Presidents:

1. Serve her council and President in a consultative capacity.
2. Be responsible for the archives and history of her council.
3. Facilitate and encourage the study and implementation of the Constitution & Bylaws.

### **Consultative**

It may be difficult for some of us to move on and become the "voice of experience" after the busy years of being a Council President. Past Presidents must be prepared to listen carefully and only provide advice when asked or needed. We must be ready to embrace change and encourage confidence in the new executive. Let the new President bring her leadership and style to shape the council during her term in office. Use your experience constructively when offering advice. Always be guided by the Holy Spirit in all you do!

### **Archives**

During my term as President, I realized that archives aren't dusty, old books that aren't important. To quote the *Handbook for Past Presidents*, "archives are important historical material from which information, inspiration, and enthusiasm for the League may be derived. They also serve as permanent, lasting records of the achievements of the organization." I can't begin to relate how many times I investigated the history of our CWL when planning remarks, visiting councils, and understanding where we had been and how we have impacted our diocese. I discuss how to archive in another communique, especially addressing archives.

### **Constitution & Bylaws**

As a past President, it is vital to understand the rules and laws governing our organization. If we still need to be fully conversant on the rules guiding us in League protocol and policy, this is the time to study and become conversant.

We need to keep the Constitution and Bylaws close at hand for reference. With the recent amendments to the Constitution and Bylaws 2013, it will be essential to work within your councils to understand the amendments and incorporate them into your own council and policy procedures.
